

## WATFORD BOROUGH COUNCIL

### THE BOROUGH OF WATFORD (VARIOUS ROADS, WATFORD) (PROHIBITION OF WAITING) ORDER 2021

1. NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council (the County), and in exercise of the powers conferred on that County under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.
2. The general effect of the Order would be to provide **'no waiting at any time'** waiting restrictions in the locations specified in Schedule 1 of this Notice, **'no waiting Monday-Saturday 6am-6.30pm'** specified in Schedule 2 of this Notice, **1 hour limited waiting 8am-8pm Monday to Sunday** in Schedule 3 of this Notice, **Loading Only 8am-8pm Monday to Sunday** in Schedule 4 of this Notice and parking for **Blue Badge Holders Only** in Schedule 5.

#### **SCHEDULE 1 – Proposed 'No waiting at any time' restrictions**

- (1) At the junctions of **St Georges Road with Gammons Lane, Pope Lane & Maude Crescent**
- (2) At the junctions of **Garston Drive, with St Albans Road, Gwent Close & The Pippins**, along with the east side of The Pippins
- (3) At the junction of **Westwick Place with Sheepecot Drive**
- (4) At the junction of **Blackthorn Close with Louvain Way**
- (5) At the junction of **Horseshoe Lane with Orchard Avenue**
- (6) At the southern side of **Balmoral Road, east of Eastfield Avenue.**
- (7) At the junction of **The Brow with Newhouse Crescent**
- (8) On **North Approach** across the emergency access of Kingsway Infant School
- (9) Within **Fern Way**, around the inner and outer bends, on the north eastern, south western, north western and south western sides.

#### **SCHEDULE 2 – Proposed 'No waiting Monday-Saturday 6am to 6.30pm restrictions**

- (1) At the junction of **Neston Road/Parkgate Road**
- (2) At the junction of **Buckingham Road/Sandringham Road**

#### **SCHEDULE 3 – Proposed Limited Waiting 1 Hour No Return with 1 Hour Monday to Sunday 8am to 8pm.**

- (1) Within the Layby on the north side of **The Brow**, located between Louvain Close & Newhouse Crescent

#### **SCHEDULE 4 – Proposed Loading Only Monday to Sunday 8am to 8pm.**

- (1) Within the Layby on the west side of **Newhouse Crescent**, north of the Brow

#### **SCHEDULE 5 – Blue Badge Holders Only.**

- (1) One bay, within the Layby on the north side of **The Brow**, located between Louvain Close & Newhouse Crescent
  - (2) Two bays, on the west side of **Greenbank Road**, north of Holy Rood Primary School.
3.
