NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council (the County), and in exercise of the powers conferred on that County under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

- 1. The general effect of the order would be to provide 'No Waiting At Any Time' waiting restriction at the following locations.
 - At the junction of Westfield Avenue and Munden Grove
 - On the north side of the Garston Park Parade service road, outside property no. 16.
 - On the north side of Riverside Road, either side of the access to Riverside Road Industrial Units
 - At the junction of Bushey Mill Lane and Radlett Road
 - Around the north western side of the Trevellance Way and Newlands Walk junction
 - On the western side of Albanwood, between the junction with Newhouse Crescent and property no.
 95 Albanwood
 - At the junction of **Stud Green** and **Ganders Ash** and The Bow
- 2. The effect of the order is to provide 'No Loading At Any Time' waiting restriction at the following locations:
- On west and east side of Ascot Road, between the Toyota Car Garage and Morrisons Supermarket
- 3. The effect of the order is to provide 'No Waiting Monday Saturday, 11am 12pm' waiting restriction at the following location:
- On the east side of **Cow Lane**, along the unrestricted section of carriageway in the northeastern direction from the junction with St. Albans Road
