Introduction

The Infrastructure Funding Statement (IFS) is an annual report that has to be published by 31st December each year.

This report is produced by Watford Borough Council and provides a summary of financial developer contributions secured either through Section 106 Agreements or Community Infrastructure Levy (CIL) payments for the financial year 2023/24.

It does not include information on contributions listed within Section 106 Agreements payable directly to Hertfordshire County Council or on infrastructure that is delivered under Section 78 agreements, or directly by developers.

Community Infrastructure Levy

Watford became a Community Infrastructure Levy (CIL) Charging Authority on 1 April 2015. CIL is the main way in which the council now collects contributions from developers for infrastructure provision to support development in the Local Plan.

Our CIL income is split in accordance with the regulations in the following way:

- 5% is used to administer CIL in Watford
- 15% of the money received will be spent on priorities to address demands that new development places on our neighbourhoods in Watford. This portion of the income is referred to as Neighbourhood CIL (NCIL)
- The remaining 80%, will be spent on infrastructure projects that benefit the whole borough. This is referred to as Watford's Strategic CIL.

Neighbourhood CIL

As Watford is not parished, the neighbourhood portion received is set aside by the council to spend on community infrastructure projects.

The following priorities have been identified for Neighbourhood CIL spending.

NEIGHBOURHOOD CIL PRIORITIES

- Town and local centres
- Transport and roads
- Community spaces and cultural facilities
- Parks and green spaces
- Sustainability and Climate Change initiatives

Our first programme of allocating NCIL was launched in June 2022 with our new 'Neighbourhood Grant' process.

In 23/24, a total of £249,000 from Neighbourhood CIL was allocated and distributed between 17 local infrastructure projects as follows:

- One YMCA: Creating ICT Suite in Charter House for employment training (£30,000)
- Safer Watford: Enhancing Victoria Passage for accessibility and town vitality (£76,000)
- Watford Community Housing: Upgrading play space in Foxhill (£12,500)
- Watford & Three Rivers Trust: Improving community facilities at The Barn (£17,676)
- Watford Area Arts Forum: Workshops on 'the planet' and recycling benefits (£3,000)
- The Watford Gurwara: Establishing a phone box library with free books (£12,000)
- Goods for Good (Global): Training program for Watford Hostel residents (£4,842)
- Random Cafe CIC: Café accessibility improvements (£9,840)
- Friends of Lanchester: Funding for year-round use of an adventure playground (£10,000)
- Home Start Watford & Three Rivers: Additional family support in Central Watford (£4,695)
- Nascot Residents Association: Community-designed ward sculpture (£3,000)
- Watford Mencap: Accessible soft play building for children with disabilities (£20,000)
- Pump House Theatre: Upgrades for improved access and facilities (£14,255)
- West Watford Community Association: Centre visibility enhancements (£4,222)
- Watford Workshop: New mezzanine level for disability support (£20,000)
- West Herts ABC: Boxing sessions targeting disadvantaged youth (£5,000)
- Friends of Oxhey Park: Defibrillator installation at café (£2,663)

Strategic CIL projects

In 23/24, a total of £3,169,058 was allocated as follows:

- £2.4m to fund the Colosseum project towards the maintenance and operation of the Colosseum;
- The HCC CIL bid for Breakspeare school was approved by Cabinet to allocate £769,058 of Watford Borough Council Community Infrastructure Levy funding towards the relocation and expansion of Breakspeare School.

S106 Planning obligations

Under section 106 (s106) of the Town and Country Planning Act 1990 a Local Planning Authority (LPA) can mitigate the potential impacts of new development through planning obligations when it is considered that the impacts cannot be appropriately mitigated through conditions on the planning permission.

The obligations may be provided by the developers "in kind" – that is, where the developer builds or directly provides the matters necessary to fulfil the obligation e.g. this might be to build a certain number of affordable homes on- site. Alternatively, planning obligations can be met in the form of financial payments to the Council to provide off-site infrastructure works or contributions towards providing affordable housing elsewhere in the Borough. In some cases, it can be a combination of both on-site provision and off-site financial contributions.

The obligations within a S106 agreement must meet three legal tests;

- Necessary to make the development acceptable in planning terms;
- Directly related to the development; and
- Fairly and reasonably related in scale and kind to the development.

Due to these tests, contributions secured through s106 agreements will normally be subject to more detailed restrictions in terms of how these contributions can be allocated and spent.

Obligations requested by Hertfordshire County Council (as service provider) are often included within the S106 agreement and are paid directly to them. This report does not include information on contributions listed within Section 106 Agreements payable directly to Hertfordshire County Council or on infrastructure that is delivered under Section 78 agreements, or directly by developers.
