PUBLICART COMMISSION: ARTIST'S BRIEF AND REQUEST FOR PROPOSAL

Background

1.1 Pilot Project:

Tales of the River project is part of Watford Borough Council's groundbreaking 10-year programme to restore the River Colne, a rare chalk river, one of only around 200 in the world. Not only has the river shaped the Watford we know today with its rich history, it is also a vital corridor for wildlife cutting through an urban landscape, it also has potential to once again be a valuable outdoor space for the whole community to enjoy. The 'Landscape strategy & access improvement' report Rediscovering the River Colne September 2020 created by our programme partner Groundwork highlighted there were many opportunities for introducing arts and heritage to the river corridor involving professional artists and the local community.

We recognized that the restoration of the River Colne requires a long-term commitment from our partners and the community to protect this valuable asset for generations to come. Our challenge has been to try and restore an appreciation of our forgotten river for Watford's long-standing residents along with reaching out to our newer diverse community. In October 2022 Watford Borough Council (WBC) were successfully awarded National Lottery Heritage Funding (NLHF) to deliver 'Tales of the River'. This project tells the next chapter in the river's story through a programme of events and activities between March 2023 and August 2025, designed to strengthen links between the river's natural and industrial heritage and the communities that live, work, and spend time in and around Watford.

One of the approved purposes for this project is to commission a new public art installation which must be delivered ahead of the end of the project in August 2025.

1.2 The Commission

The objective of this commission is to deliver an individual or series of permanent public artworks which respond to the creative writing elements of Tales of the River.

Since January 2024, two Artist led Creative writing and Poetry workshop series have been delivered ,engaging a multigenerational community Scout group and a group of local Primary school children.

We envision the outputs of these projects to inspire the Public Art piece and are open to ideas such as using text, oral histories and images to respond to these with a focus on natural and locally sourced materials.

As part of this project the council has commissioned writers to deliver two pieces of written poetry to accompany the participants' work. We are keen to reflect on this work through the artist's approach and would encourage this to inspire their vision.

The client is Watford Borough Council. The project will be project managed by the council's Arts Development Officers, who will provide project support in terms of planning permission and sign off.

Watford Borough Council has recently produced a Public Art Strategy and associated Public Art Commissioning Toolkit. This commission will incorporate the testing of processes outlined in the Toolkit and will strive to adopt the principles set out in the Strategy. **See Appendix 1.**

1.3 Suggested Sites

Some areas have been identified as particular impact with regards to the wider project and activity. The Radlett Road destination area being of particular interest other sites of some interest are Knutsford and Riverside following along the trail left by existing pieces. **See Appendix 2.**

Applicants will be invited to a site tour of the area and discussion on the project so far (see timeline)

2. Approach

This opportunity is for an artist to work collaboratively with the council project team to build and deliver an engaging and inspiring piece of art that enhances the area and reflects the Creative writing elements through this unique and collaborative NHLF project.





As outlined within the project outcomes so far, we invite artists and creative practitioners to interrogate this unique site, respond to the writing and make proposals for innovative ways to celebrate and reimagine what the River Colne could offer.

We are open to the artist's own approach on material and style and strongly encourage approaches that reflect the writing and writing outreach activities which have already been carried out. **See Appendix 2.**

3.0 Specific commission requirements:

Create an artwork or series of artworks that:

- Has a design life of at least 10 years
- Robust materials
- Require minimal maintenance
- Access and Inclusion for all
- Consideration of sustainable materials where possible

The successful artist will be required to work in liaison with the council project team and should allow for at least one meeting a month with the project group during the design development period.

There will be a client meeting to decide whether to go ahead with the initial proposals before the detailed design work and fabrication starts.

Part of this process will include assisting in the preparation of and participating in any presentations to Watford Borough Council as required, for the purpose of planning consent and internal sign off.

The final design, materials / finishes are subject to discussion/agreement with and the approval of the Client

3.1 Budget

The budget for the commissions is £13,000 (+ VAT) to cover:

- artist's fee and any fees/payments to assistant(s), travel, studio expenses,
 technical / CAD drawings, digital / sound files and admin costs
- . on-going liaison with the Client to realise this commission





- participation in any presentations to the Client
- . Planning and any other consents
- . All fabrication and installation of the work with associate costs and insurances.
- . Budget, and all costs will be managed by the Artist. Some support will be provided by the client's project team.

4. Artist's Proposal requirements

- The following information is required in order to evaluate the Proposal. A brief visual and written proposal responding to the brief and outlining your approach. To include your concept and relation to the curatorial theme /project activity and themes. (no more than 4 sides of A4)
- ii. Evidence of similar projects delivered, including collaborations,





with their budget and processes involved.

- iii. Please note we may ask for references from previous commissions as well.
- iv. A pricing schedule detailing full costs for completing the work.
- v. A proposed timescale for completing the work such as a gantt chart.

5. Evaluation approach

The Contract will be awarded on the basis of the most economically advantageous and qualitative Tender to the Council. The Council's decision to accept or reject a Tender will be in accordance with the Public Contracts Regulations 2015, the provisions of the Local Government Acts 1988 and 1992 and the various Regulations and Guidance issued there under.

Prior to evaluating the Tenders, the Council will carry out an initial review to confirm completeness and compliance with the Tender requirements and may, at its discretion, reject a Tender which is incomplete and/or non-compliant.

The Council has established an evaluation methodology and will be carrying out the evaluation of Tenders by applying the methodology set out below.

The Council reserves the right to make contact with and visit supplied references.

Tenders that do not contain all complete and correct information (including supporting evidence for evaluation purposes) may be rejected by the Council. The Council does not undertake to award the Contract to the lowest priced or any tender, and reserves the right to cancel or withdraw the Procurement at any stage; and/or not to award a Contract.

5.1 Evaluation methodology

Quality scores will be determined against the following criteria.

Score	Rating	Criteria for Assessing Score
5	Excellent	The bidder has provided a response that fully meets requirements, is robust and supported by suitable and relevant evidence of experience and technical and professional ability. Furthermore, the response demonstrably exceeds or adds value above the Council's stated requirements.
4	Good The bidder has provided a response that is robust and supported by and relevant evidence of experience and technical and professional fully meets requirements.	





Score	Rating	Criteria for Assessing Score
3	Satisfactory	The response is compliant and the bidder has provided responses that demonstrate they nearly meet the requirements but there is some detail lacking in the response. The response has not fully met requirements.
2	Fair	The response is generic. The bidder has provided insufficient response or the response given demonstrates limited experience and limited technical and professional ability to meet the Council's requirements
1	Poor	The bidder has provided wholly insufficient responses or the response given demonstrates very limited experience and insufficient technical and professional ability to meet the Council's requirements. Should any potential bidder be allocated with this score, its bid submission may be rejected.
0	Unacceptable	The bidder has not answered the question, has omitted information or has provided information that is not relevant and the Council is unable to determine whether the bidder possesses sufficient technical and professional ability. Should any potential bidder be allocated with this score, its bid submission may be rejected.

Cost scores will be determined by awarding the bidder providing the lowest overall net cost to the Council maximum points and other Bidders will be awarded points on a pro-rata basis.

5.2 Evaluation Criteria and Weightings

During this you will be required to present to the Selection Panel, giving a short presentation on your practice and discuss your initial response to the brief. This is not a request for a detailed design, but just your approach.

Please do notify us if you have any access needs, we will do our best to accommodate these where possible. The format and agenda for the presentation will be issued to the artist in advance.

A proposal fee will be paid to undertake this work which will include any travel and other associated and reasonable expenses.


