

ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF WATFORD (ALDENHAM ROAD, CHALK HILL & PINNER ROAD, WATFORD) (PROHIBITION OF WAITING) ORDER 2021

WBC Order No. 21/05

NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under Sections 1, 2 & 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (referred to as "the Act") and all other enabling powers.

The general effect of the Order will be to introduce **No Waiting at Any Time restrictions in place of the existing No Waiting Mon-Sat 8am-6:30pm restrictions** at the following locations on the Bushey Triangle gyratory system;

- Aldenham Road
- Chalk Hill
- Pinner Road

In accordance with Part IV of Schedule 9 of the 1984 Act, the parts of the BOROUGH OF WATFORD (OXHEY AND BUSHEY ARCHES AREA) (PROHIBITION & RESTRICTION OF WAITING, LOADING & UNLOADING) ORDER 1998 described in the schedule to this proposed Order are to be revoked. **A Plan detailing the proposals is attached to this notice.**

Due to the difficulty for local authorities to make documents relating to Proposed Traffic Regulation Orders available for public inspection in their offices during the coronavirus pandemic, **The Traffic Orders Procedure (Coronavirus) (Amendment) (England) Regulations 2020**, (which came into force on 23 May 2020) have been introduced to enable local authorities to put alternative arrangements in place to make documents available to the public.

The following alternative arrangements are in place to allow the public to view or obtain copies of documents giving further details of this proposal:
