

**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT)  
(England) ORDER 2015 AS AMENDED**

**IMMEDIATE DIRECTION MADE UNDER ARTICLE 4 (1) OF THE ORDER**

WHEREAS the Council of the Borough of Watford being the appropriate local planning authority within the meaning of article 4(4) of the Town and Country Planning (General Permitted Development)(England) Order 2015, as amended, are satisfied that it is expedient that development of the description set out in the Schedule below should not be carried out on the dwelling at the following address, **8 Garden Close Watford, WD17 3DP**, unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990 as amended.

NOW THEREFORE the said Council in pursuance of the power conferred on them by article 4(1) of the Town and Country Planning (General Permitted Development) (England) Order 2015, as amended, hereby direct that the permission granted by article 3 of the said Order shall not apply to development on the said land of the description(s) set out in the Schedule below.

THIS DIRECTION is made under article 4 (1) of the said order and, in accordance with Schedule 3 paragraph 2 (6), shall remain in force until 26<sup>th</sup> May 2020 (being six months from the date of this Direction) and shall then expire unless it has been confirmed by the local planning authority in accordance with paragraphs (9) and (10) of Schedule 3 before the end of the 6 month period.

**SCHEDULE**

**Part 1:**

Class A – The enlargement, improvement or other alteration of a dwellinghouse.

Class B – The enlargement of a dwellinghouse consisting of an addition or alteration to its roof.

Class C – any other alterations to the roof of a dwellinghouse.

Class D – Erection or construction of a porch outside any external door of a dwellinghouse.

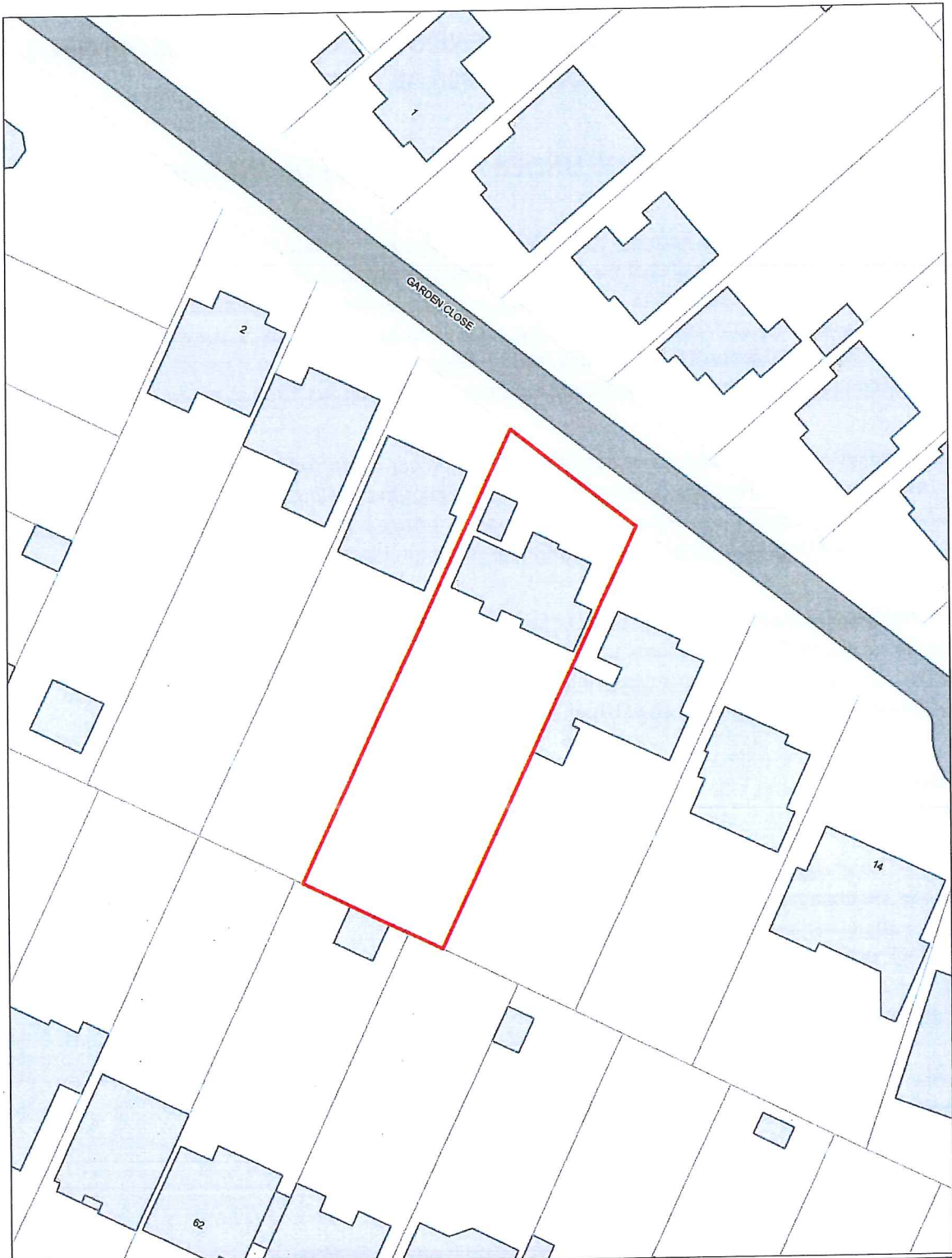
Class G – The installation, alteration or replacement of a chimney, flue or soil and vent pipe on a dwellinghouse.

**Part 2:**

Class C – The painting of the exterior of any building or work

**Part 11:**

Class B - Any building operation consisting of the demolition of a building.

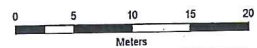
